High-Level Working Group on Health and Human Rights of Women, Children and Adolescents Agenda item 16.3

"Global Strategy for Women's, Children's and Adolescent's Health"

I have the honor to deliver this statement on behalf of 46 CSOs

- We commend the work of the High-Level Working Group for the Health and Human Rights of Women, Children and Adolescents jointly initiated by WHO and OHCHR and very much welcome the recommendations of this High-Level Working Group;
- Too often human rights and fundamental freedoms, including sexual and reproductive health and rights are neglected around the world, and harmful social, gender, cultural norms and structural barriers persist with great consequences to women's, children's and adolescents' lives, dignity and wellbeing. The challenges and opportunities have been identified and we all know what the solution is. A human rights' based approach to health policies and programmes, based on the WHO constitution, the International Covenant on Economic, Social and Cultural Rights and other relevant Human Rights instruments, is fundamental if we want to bring change and ensure the fulfilment, protection and respect of all human rights and fundamental freedoms by all.
- The principles of gender equality, non-discrimination, non-violence, inclusiveness, participation and transparency must be the basis for any Government or local authority when developing their health national and subnational strategies, as well financial strategies.
- Solid accountability mechanisms at the various levels of decision making need to be put in place. Let's not forget that Governments must be accountable to the people and for the people. Evidence based and data collection needs to be strengthen and well-funded, without which it won't be possible to have effective and meaningful monitoring and evaluation mechanisms, and ultimately develop and implement informed policies to overcome obstacles and truly make a difference on people's lives.
- Members of society in general need to be protected and empowered to claim their human rights. A safe space for CSOs to work needs to be guaranteed, and partnerships with Governments and the UN system and other stakeholders developed.
- We endorse the call for the Director-General of WHO and the High Commissioner for Human Rights to establish a joint programme of work to support the implementation of these recommendations and create the necessary institutional capacity and expertise at global, regional and country levels to coordinate, track progress towards the fulfillment of human rights, including sexual and reproductive health and rights, to and through health especially for women, children and adolescents.
